#### SMALL BUSINESS DEVELOPMENT CENTER (SBDC) OUTREACH OFFICE

TCDC's North Central Regional Outreach Office logged 126.75 hours

of billable SBDC technical business assistance to in 2017. Our SBDC technical assistance services are "FREE" to anyone who signs up with the SBDC system. TCDC also provided another 54 hours of free non-SBDC assistance that was provided to businesses throughout Todd County. Additionally 40 hours of required continuing education (marketing, finance, technology, etc.) were logged to meet SBDC certification with the North Central SBDC office at Central Lakes College, State of Minnesota Department of Employment and Economic Development (MNDEED) and Federal Small Business Administration (SBA).

#### TCDC "REVOLVING LOAN FUND" (RLF)

The TCDC RLF began in 2011 with a balance of \$113,000 dollars originating from a MN DEED "Minnesota Investment Fund" loan repayment dedicated for economic development. TCDC identified an opportunity to apply for a USDA Rural Development "Rural Business Enterprise Grant" (RBEG) and received funding of \$99,000 dollars in late 2011. RLF dollars are loaned to good business projects at a lower fixed interest rate and favorable terms. Since January of 2012, \$247,400 has been loaned to local businesses, with \$140,000 of those loans paid in full plus interest. All loans have been current and no late payments. As of December 31, 2017, the TCDC RLF had an asset amount of \$237,470 dollars, up \$25,470 over a five year period.

#### 2016 TCDC ANNUAL DINNER

The TCDC 4th Annual Dinner had a total of 72 participants (not including Directors, Volunteers and Staff). Dan's Prize was the dinner sponsor and the TCDC Board of Directors prepared and served the meal. Business recognition awards were presented to the following:

#### **"THE GOOD LIFE" REGION FIVE** MARKETING WEBSITE

In early 2017, Region Five Development Commission and economic development professionals were finalizing the marketing brand and website design of the new Region Five "The Good Life" website. The purpose of the website

was to develop a region-wide brand, help attract workforce talent to our communities and market the amenities within our region. The official Region Five "The Good Life" website was launched in June of 2017. As part of the NJPA Innovation grant, we were able to include nearly \$40,000 for community branding projects. Applications for these community grants included awarding \$5,000 for the Staples community wide marketing campaign and \$3,500 for marketing the Cinco de Mayo event in Long Prairie.

The Region Five "Good Life" website became a reality through the work of Region Five county economic development professionals and Region Five Development Commission. A \$100,000 National Joint Powers Alliance (NJPA) Innovation Grant was secured and the Golden Shovel Agency was retained to help develop the regional economic development website. As an "in-kind" match, Region Five Development Commission and all 5 county economic development professionals contributed to the process to prepare the application and help provide content. Earlier in 2016, TCDC had launched their own Golden Shovel website and used content available through their website for the "Good Life" regional website. To further the content on both TCDC and "Good Life" regional website, TCDC retained the assistance of a NJPA summer intern to provide assistance incorporating updates and content. Website improvements included business/community resources, site selection and adapting a "snap shot" feature on all community pages with and the ability to access complete community and county demographic data. #### **TIMBERLAKE HOTEL IN STAPLES**



Through the efforts of the City of Staples TCDC, the Timberlake Hotel and Event Timber Lake Center was completed in Staples. The HOTEL project began construction in the fall of 2016 and opened for business in June of

2017. Seventy Five percent (75%) of the construction workers on this project were local.

The Timberlake Hotel and Timbers Event Center in Staples, is a smaller version of the much larger Timberlake Lodge and Event Center in Grand Rapids. The owners, Ives Family, operate multiple hotel and rental properties throughout the Midwest. The new facility is located on the north side of Highway 10, next to NJPA and Dairy Queen in Staples.

#### **BLANDIN FOUNDATION'S "LEADERSHIP IN ETHNICALLY** DIVERSE COMMUNITIES" PROGRAM

Last fall, the Blandin Foundation held a new program in Long Prairie, "Leadership in Ethnically Diverse Communities" (LEDC). This program is designed to help build relationships and develop leadership capacity in ethnically diverse communities. The participants represented all sectors of the Long Prairie community. TCDC was part of the volunteer steering committee that had a goal of 24 participants for the "Leadership in Ethnically Diverse Communities" (LEDC) program. The program began in September and continued through October with a total of 4 sessions.

#### STUDENT SUCCESS DAY AT CENTRAL LAKES COLLEGE (CLC) - STAPLES

On October 20th, Melissa Radermacher of the Staples EDA and Rick Utech of TCDC presented "Going into Business" to 38 incoming students. The community resources presentation was held at the CLC campus in Staples. Students participated in two break-out sessions sponsored by the Staples EDA and TCDC.

#### WORKFORCE HOUSING

TCDC has been working with the City of Long Prairie and Eagle Bend on potential workforce housing to support the housing needs of our industry. The City of Staples has been working with developers to create new workforce rental properties over the past few years.

Recent meetings with the City of Long Prairie, Central Minnesota Housing Partnership and Jacki Anderson of Congressman Colin Peterson's office have taken place on potential workforce housing projects in the Long Prairie area. Workforce rental housing is essential to help our business grow and a priority for TCDC in 2018.
